

Chris Davies, Conservative MP for Brecon & Radnorshire

- Bought and submitted expenses claim for pictures in his constituency office, to the value of £700
- Charged with two counts of making a false instruction; and one count of false misleading information for purposes of allowance claim.
- 'Created' 2 new invoices for £250 and £450
- Due to appear in Southwark Magistrates court 22 March 2019
- Pleaded guilty, meeting third Recall Petition condition



Recall Petition Conditions

- 1. the MP has, after becoming an MP, been convicted in the United Kingdom of an offence and sentenced or ordered to be imprisoned or detained, and any appeal period has passed without the conviction being overturned.
- 2. Following on from a report from the Committee on Standards in relation to an MP, the House of Commons orders the suspension of the MP from the service of the House for a specified period (at least 10 sitting days, or at least 14 days if sitting days are not specified).
- The MP has, after becoming an MP, been convicted of an offence under section 10 of the Parliamentary Standards Act 2009 (if they provide information which they know to be false or misleading in a material respect in support of a claim for allowances).

Advice

- Appoint same petition staff for the full 6 weeks




